FROM THE MAYOR'S DESK

As with any organization, its people are its strength and I and the Borough Council have worked diligently to ensure that our administrative staff lead by our Borough Clerk Dorothy Hicks continue to serve our residents with professionalism and efficiency. By structuring service hours of our employees we have effectively increased the hours that administrative personnel are there to serve you while maintaining a very cost effective result for our taxpayers. Speaking of taxes, by working closely with our CFO Debra Stern, I and the Borough Council were able to actually reduce our municipal tax rate for the Borough of Far Hills in 2017 while continuing to provide a sustainable plan of infrastructure improvements and maintaining a rainy day fund should we need it, something we all should be very proud of.

Our Police Department continues to do a wonderful job, and under the direction of Chief Michael DeCarolis we continue to address your concerns. Speeding through and around Far Hills has been an issue as motorists rush to their destinations. To address that we have taken many measures such as additional patrols during rush hour, speed warning signs have been purchased and are rotated throughout the Borough and most importantly, enforcement on all roads with special attention to cut-through roads such as Dumont Road, Lake Road, Railroad Avenue and others, are part of regular interdiction. These and other measures will continue to ensure the safety of our residents. I would like to welcome, Officer Demetrios (Jim) Peslis who comes to the Borough with many years of experience and will be an additional asset to our Far Hills Police Department. I would also like to welcome, Janet Seylaz, Administrative Assistant in the Office of the Borough Clerk, and Kimberly Coward, Zoning Officer to our Far Hills team.

Our Far Hills business district continues to grow as we welcome several new businesses including The Red Toad, a women's clothing shop, a coffee shop, a skin care salon, and a delicatessen coming to the Mall at Far Hills this fall, and other business services are on the way. After much effort and discussion, the Butler's Pantry Trackside Restaurant signed a new lease and what has been a favorite establishment for many of our residents will continue to serve breakfast, lunch and dinner in an improved and more visually appealing environment.

I want to commend the members of the Planning Board for the due diligence, time and effort that they devote to ensure that the pastoral and bucolic nature of Far Hills is maintained while encouraging growth in our business sector. I encourage our residents to support these and all of our businesses as often as possible. Improvements around the Borough continue as a few decaying trees on Borough property by the J. Malcolm Belcher Fairgrounds have been removed and new trees will be planted. We are working with Somerset County and "Go Green" initiatives to assist with the cost of these new trees and the planting of such. New sidewalks will replace the sections around the fairgrounds that are cracked and which are in need of replacement. Working collaboratively with neighboring Bernards Township, a section of Douglas Road was recently resurfaced and additional road projects are being evaluated for 2018. Remember that road resurfacing is extremely expensive and I and the Borough Council continue to work with the New Jersey Department of Transportation and Somerset County to obtain as much grant funding as possible to offset the cost wherever possible.

The VNA Fall Rummage Sale was held October 6 - 9, 2017 and was a huge success. I encourage everyone to support these biannual sales as it enables the VNA to provide much needed services to those in need. Saturday, October 21, 2017 will be the Far Hills Steeplechase and it should prove to be a wonderful family event. I, the Borough Council and our Chief of Police have worked with the State Police, County Police and Prosecutor's office to continually improve the experience for all. This year, additional measures are being taken and enforced by law enforcement to further address underage drinking.

Finally, I want to thank you, our residents, for your continued support. As I have said many times, working together and from a positive perspective, there is no issue that we cannot solve, no issue too great. KNOW THE FACTS BEFORE AN ENCOUNTER!

There is an increase in the population of bear and coyote in New Jersey. If you encounter an aggressive bear or coyote immediately notify local police or the DEP's Division of Fish and Wildlife at 1.877.WARN.DEP.

IF YOU ENCOUNTER A BEAR:

- Do not feed or approach the bear! Bears are wild animals and their behavior can be unpredictable.
- Remain calm and make the bear aware of your presence by speaking in a loud, assertive voice, singing, clapping your hands or making other noises.
- Avoid direct eye contact, which may be perceived by a bear as a challenge. Never run from a bear! Instead, slowly back away. If you are with someone else, stay together in a group.



SAFETY TIPS FOR HOMEOWNERS:

- Put garbage out on collection day, not the night before.
- ♦ Clean outdoor grills and utensils thoroughly after each use and store grills securely. Grease and food residue attract bears.
- Avoid feeding birds if you live in an area frequented by bears. Birdseed also attracts rodents and other coyote prey.
- Avoid feeding pets outside and bring them in at night.
- Free roaming pets, especially cats may attract coyotes to the neighborhood.
- ♦ Install motion-sensitive lighting around your home.

FALL LEAF CLEAN UP HELP AVAILABLE

MAINTAIN THE DRAIN—WHY IT MATTERS

- ♦ Litter and leaves can clog a storm drain, causing rainwater to back up onto your property and into your home.
- Debris that washes into a storm drain can travel underground through pipes and come out into lakes, rivers, streams and even the ocean.
- ♦ Litter can attract rodents and disease, posing a health risk.
- ♦ Litter can pose a risk to animals and marine life as sometimes it can be mistaken for food and ingested.
- Maintain your car as fluid leaks can contaminate the roadway and rainwater can carry it into fresh water!

IDENTIFYING & PREVENTING STORMWATER POLLUTION



Storm water runoff is water from rain that does not soak into the ground. It flows from rooftops, over paved areas, bare soil, and sloped lawns. Municipal storm sewer systems, storm drain inlets, pipes and ditches collect storm water runoff and convey it directly to local bodies of water.

Ideally, the storm water runoff is contaminant free. In reality, it picks up pollutants such as soil, animal waste, salt, pesticides, fertilizers, oil and grease, and debris and transports them to waterways where they are discharged with no treatment. This is storm water pollution.

Disposal of anything other that storm water in storm sewers is illegal. It is important to remember that municipal storm sewer systems are not set up to treat or process anything and exist solely to transport rain water to surrounding river, streams, and other bodies of water.

THINGS YOU CAN DO TO PROTECT OUR WATER QUALITY

- Never dump anything down storm drains
- Dispose of household waste properly
- Use fertilizer sparingly, sweep up any excess from driveways, sidewalks and roads
- Avoid pesticides
- Pick up after your pet
- ♦ Direct downspouts onto grassy areas away from paved surfaces
- ♦ Check vehicles for leaks
