Borough Council Regular Meeting MINUTES

September 10, 2018

CALL TO ORDER

Mayor Vallone called the meeting to order at 7:00 p.m. at the Fat Hills Municipal Building and read the open public meetings statement in accordance with the law.

PRESENTATION

Messrs. Guy Torsilieri and Ron Kennedy, Far Hills Race Meeting Association provided an overview of the event scheduled for October 20, 2018. Mr. Torsilieri stated that this would be the 98th year of the Race Meeting. He also outlined the process for the pari-mutuel wagering that would take place for the first time this year. Mr. Torsilieri also informed the Council that fundraising efforts have been expanded to assist additional charities in the local community.

He commented that he has also reviewed the requested parking restrictions on Peapack Road and the proposed shared service with Bernards Township for improvements to Mine Brook Road via a NJDOT grant.

Lastly, he commended Councilman Hand on the landscaping improvements to the NJ Transit Train Station.

Council President Karner - Police

Mayor Vallone

Mr. Sordillo reported that the Borough would be providing a status report only to Judge Miller on September 12, 2018, as a case management conference had not yet been scheduled.

Mayor Vallone opined, that due to considerable public opposition, the Bernardsville Borough Council was planning to rescind the original zoning for the transfer station. Mayor Vallone added, as a proactive measure, the Borough of Far Hills sent a letter to the NJDEP officially opposing the truck route.

Michael Joyce, 57 Liberty Corner Road, Far Hills commented that the Quarry site was originally planned for affordable housing.
