Borough Council Regular Meeting MINUTES

September 24, 2018

CALL TO ORDER

Mayor Vallone called the meeting to order at 7:00 p.m. at the Far Hills Municipal Building and read the open public meetings statement in accordance with the law.

REPORTS

Councilman Hand - Fire, Water, Light, Buildings & Grounds

No report.

Councilwoman Tweedie - Health/Sanitation

Councilwoman Tweedie reported that smoke testing of the sewer system was completed in August 2018 for the Polo Club and Sunnybranch Road areas. It was noted that 9 broken clean out caps were discovered out of approximately 128 homes being tested and were determined to be minor sources of inflow. A review of the manhole covers indicated that they were performing adequately. Councilwoman Tweedie noted that inflow and infiltration (I&I) testing would continue in the Village area of the Borough.

Councilman Surks - Roads

Councilman Surks provided a brief overview of the status of the Ludlow Avenue Road Improvements Project and reported that this morning he, Borough Engineer Paul Ferriero and Ms. Hicks met individually with each of the contractors who submitted a Notice of Interest to review the scope of the project to ascertain additional areas for cost savings. The contractors were asked to submit a best and final proposal by October 1, 2018. Councilman Surks noted that it may be advisable to postpone this project until spring 2019, due to the wear and tear on the roadways during the winter months.

Councilman Carty - Finance/Insurance

Councilwoman Chimenti – Laws, Ordinances & Elections

Councilwoman Chimenti reported that Municipal Court deposits for the month of August 2018 were \$2,900.00.

Councilman Carty for Council President Karner – Police

Councilman Carty presented the police report on behalf of Council President Karner and Chief DeCarolis who were unable to attend the meeting this evening. He reported that Chief DeCarolis had met with the Far Hills Race Meeting Association to review law enforcement efforts for the Far Hills Race Meeting to be held on October 20, 2018. Councilman Carty noted that the police department

would monitor the increase in local traffic as a result of donation drop offs for the upcoming VNA Rummage Sale to be held October 5-7, 2018. Lastly, he reported that the Far Hills Police Department was investigating a burglary that occurred over the weekend at the Butler's Pantry Trackside.

Mayor Vallone

Mayor Vallone stated that there have been no additional updates regarding affordable housing but stated that the Borough was continuing with negotiations and a public presentation was tentatively scheduled for the Tuesday, October 9, 2018 Council meeting. Mr. Sordillo provided a brief overview of the status of the negotiations and concurred that a presentation from the developer may be planned for the next Borough Council meeting.
