

from the Mayor's desk

Dear Friends and Neighbors:

I cannot believe that 2017 has come to an end and the New Year has greeted us with a blustery and snowy beginning. I have received much feedback about these newsletters that I send to you and I appreciate your kind thoughts and comments. When I first had the honor of being elected your Mayor, I promised to keep you informed and to be available for your thoughts and questions. With your continued support, I will do so in the future, thank you.

As we take a look back over 2017, it has been quite a busy year! During this time we saw continued road projects completed with the paving of Douglas Road from Liberty Corner to the south and have petitioned the New Jersey Department of Transportation, working with our neighboring municipality of Bernards Township, to obtain a grant to pave an additional portion of Douglas Road to the north which both municipalities share. Paving and drainage improvements to Ludlow Avenue have been designed by our Borough Engineer and the project is expected to commence this spring. Remember, paving is the highest infrastructure cost a municipality has and we are always trying to obtain grants and state aid to assist us with these projects.

The Visiting Nurse Association of Somerset Hills held two successful rummage sales this past year and the Borough of Far Hills is proud to assist them in continuing their good work throughout our communities. A new event, the Essex Horse Trials debuted in Far Hills in June and was very well received. This family oriented event included a car show, food court, vendor village and, not to mention, the prestigious equestrian qualifying events. Be sure to mark your calendars as the Essex Horse Trials will be held June 23-24, 2018. The annual Far Hills Race is held each October and this year was met with pleasant weather attracting more than 35,000 people. The Race is scheduled for October 20, 2018 and provides support to many charities in our area. Each of these events takes much planning and preparation and I want to thank Chief Michael DeCarolis and our great Police Department for their contribution in keeping safety and order a priority during these events.

The Borough has just completed a sidewalk improvement project, providing new concrete walkways throughout the Borough. In addition, adjacent to the J. Malcolm Belcher Fairgrounds, old decaying and unsafe trees were trimmed or removed as necessary and new trees will be planted in the spring. With this in mind, I would like to introduce our "Adopt a Tree" program which offers donors the opportunity to dedicate a tree to commemorate an event or person in their life. Another way the Borough is going green and making a positive impact on our community is through our Clean Communities Initiative. If you or your children, either with their school or



LICENSING YOUR PET CAN SAVE ITS LIFE



A license identifies and protects your pet in case it becomes lost. You are required to renew your license annually and to keep your license updated when you move and/or your pet is given away, lost, stolen or is deceased. A license is not only a requirement, but it provides the following benefits:

- A license tells everyone that your pet is not a homeless stray.
- When licensed, found pets can be quickly reunited with their owner.
- Your license is proof that your pet has been vaccinated against rabies.

In order for a dog license or cat certificate to be issued, the owner must present proof that a licensed veterinarian has vaccinated the dog/cat against rabies. New Jersey State law requires that all rabies certificates must be valid through November 1st of the license year.

KEEP FIRE HYDRANTS CLEAR OF SNOW



When it is cold and snowy outside, you most likely will want to spend most of your time indoors. However, it's important to keep an eye on what's happening outside too. Winter weather can create fire safety hazards, such as ice and heavy snowfall that can obstruct fire hydrants. You can help reduce the risk by keeping fire hydrants accessible and clear of ice and snow. In an emergency, seconds count.

HELP PROTECT OUR WATER QUALITY

Storm water runoff is water from rain or melting snow that does not soak into the ground. It flows from rooftops, over paved areas, bare soil, and sloped lawns. Municipal storm sewer systems, storm drain inlets, pipes and ditches collect storm water runoff and convey it directly to local bodies of water.

DUMPING AND TO WAITE

THINGS YOU CAN DO TO PROTECT OUR WATER QUALITY

- Never dump anything down storm drains
- Use fertilizer sparingly, sweep up any excess from driveways, sidewalks and roads
- Pick up after your pet
- Direct downspouts onto grassy areas away from paved surfaces
- Check vehicles for leaks
- Wash vehicles on grass instead of on the driveway, or take your car to the car wash
