#### CALL TO ORDER

# Councilman Hand - Fire, Water, Light, Buildings & Grounds

Councilman Hand stated that during the VNA donation drop-off, there were reported incidents of vehicular speeding on the track at the J. Malcolm Belcher Fairgrounds. He also noted that a number of unleashed dogs have been reported at the Fairgrounds. Mayor Vallone suggested a notice regarding the leash law be placed on the Borough website as a reminder to residents.

## Councilwoman Tweedie - Health/Sanitation

#### Councilman Surks - Roads

Councilman Surks stated the Bedminster DPW would be installing stone to remediate the rut adjacent to the bridge along Lake Road. He also noted the DPW spent approximately a week patching the tertiary roads in the Borough, including Minebrook & Douglas Roads, in an effort to ensure safe road conditions.

## Councilman Carty - Finance/Insurance

Councilman Carty stated the introduction of the Borough's 2019 Budget was on tonight's agenda.

## Resolution 19-066 - Introduction of Municipal Budget for Fiscal Year 2019

Mayor Vallone presented a brief overview of the municipal budget and noted that the municipal tax rate for Far Hills was 1.6%. He stated that the 2019 budget maintains the quality of services provided to residents and the increase was attributed to additional expenses for pensions, insurance and affordable housing. Mayor Vallone highlighted that Far Hills still maintains one of the lowest municipal tax rates in the State of New Jersey. He also informed the public that a copy of the introduced budget would be available in the office of the Clerk and the Borough website. The public hearing and adoption of the budget was scheduled for the May 13, 2019 Borough Council meeting and Borough Auditor, Kathryn Mantell of Nisivoccia, LLC and Borough CFO, Debra Stern would be in attendance to answer any questions.

Charles Schwester, 410 Lake Road, Far Hills commended the Borough Council on their efforts to accommodate the request of residents to consider alternative solutions to the affordable housing mandate

and to meet with RBM Development Group. Mr. Schwester requested further information on the agreement with the Matheny School & Hospital especially inquiring about the acquisition of land for the group home development.

John Sobel, 44 Spring Hollow Road, Far Hills distributed and read letter to the Borough Council. He highlighted concerns regarding the selection process for sites for the affordable housing developments and expressed concern regarding the proposed development at 220 Route 202 – Errico Acres. He questioned the notification process regarding the Fairness Hearing and requested that an extension be sought from the Court prior to execution of the Settlement Agreement to provide for public awareness.

There were no further comments from the public.
