Cindy Campbell, 81 Peapack Road, Far Hills, inquired as to the transfer of ownership of the property at 46 Peapack Road to the Matheny School. She also questioned about the lot size, set-backs for the proposed buildings and parking and transportation requirements.

DISCUSSION GARDEN CLUB

Councilwoman Chimenti provided a brief overview of the proposed projects for the Garden Club. She indicated that the club was entirely self-funded and encouraged residents to contact Mrs. Donna Joyce to volunteer to help beautify the Borough of Far Hills.

Mayor Vallone stated that the Borough Planner, David Banisch and Borough Attorney, Joe Sordillo met with RPM Development on April 11, 2019. The Council will be presented with the findings of this meeting during Executive Session this evening and the public will be informed at a subsequent Council meeting.

PUBLIC COMMENT — The Mayor and Council welcome comments from any member of the public. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers shall limit their comments to 5 minutes.

Charles Schwester, 410 Lake Road, Far Hills inquired as to the outcome of the meeting with RPM Development.

John Sobel, 44 Spring Hollow Road, Far Hills questioned the degree of notification provided to the public regarding the proposed developments and requested that the Borough submit an extension to the Courts beyond the June 26, 2019 deadline. He requested that the public be provided additional information regarding the developments prior to proceeding to the Planning Board.

Michael Joyce, 57 Liberty Corner Road, Far Hills requested details on the June 26, 2019 deadline provided for the settlement agreement pertaining to the master plan and zoning ordinances.

Ed Coury, 100 Lake Road, Far Hills expressed concern as to the lack of response to emails submitted to the Borough Council regarding the affordable housing developments. He also expressed his appreciation to the Borough Council for meeting with RPM Development and looked forward to hearing the outcome of this meeting.

Cindy Campbell, 81 Peapack Road Far Hills, inquired as to the status of the development company she previously provided for an alternate affordable housing development. She also inquired as to the process for adopting and amending the Master Plan and the Fair Share Housing Element Plan and questioned the proposed demolition of properties along Route 202 as a component of the affordable housing development agreements.

Dr. George Mellendick, 260 Lake Road, Far Hills inquired as to what needed to be presented to the Courts by the June 26, 2019 deadline. He also commented upon the level of notification of prior meetings and hearings.

Charles Schwester, 410 Lake Road, Far Hills inquired as to the Borough's contractual obligation with the Errico Acres proposal. He also inquired as to the ownership of the property adjacent to the fairgrounds.

There were no further comments from the public.
