CALL TO ORDER

Mayor Vallone called the meeting to order at 7:00 p.m. at the Far Hills Municipal Building and read the open public meetings statement in accordance with the law.

REPORTS

Councilman Hand - Fire, Water, Light, Buildings & Grounds

No report.

Councilwoman Tweedie - Health/Sanitation

Councilwoman Tweedie reported that the inspection and videotaping of the sewer system was recently completed and during the inspection a damaged sewer main along Route 202 was discovered. It was believed to have been damaged by the installation of a utility pole by JCP&L. She noted that the Borough Environmental Engineer, Adam Stern has been actively monitoring the issue and was coordinating the repair, which may involve the closure of Route 202 and possible short term power outage. The anticipated repair cost was estimated to be \$5,000.00 to \$10,000.00 and reimbursement would be requested from JCP&L.

Councilman Surks - Roads

Councilman Surks reported that Bedminster DPW Director, John Mantz has been provided an inventory of roadways in the Borough that are in need of repair and remediation efforts were underway. Councilman Surks stated that repair work on the culvert on Lake Road was pending the review by Somerset County.

He continued stating that NJDOT approved the modification of scope for the Mine Brook Road project which should lessen the financial impact of the project. Lastly, he reported the Douglas Road, Section 2 road project bid opening was scheduled for July 9, 2019 at 10:45 am in Bernards Township.

Councilman Carty - Finance/Insurance

No report.

Council President Karner - Police

Council President Karner presented the June 2019 police report. He stated that "No Parking" signs were being installed along a section of Peapack Road.

Council President Karner reported that he and Councilman Carty have been progressing PBA negotiations and Borough's Human Resources Officer, Jill Searing was preparing a benchmarking analysis.

Chief DeCarolis

Chief DeCarolis stated that the Police Department could provide vacation property checks for residents.

Mayor Vallone

Mayor Vallone asked Mr. Sordillo to provide an update regarding the status with the Court and Fair Share Housing Center (FSHC). Mr. Sordillo responded that he had a conference call with Judge Miller this morning and a follow-up conference call was scheduled for July 24, 2019 in order to provide continual updates to the Court regarding the Borough's progress. He noted that a draft order to outline the timeframe for submission of documents was currently being reviewed with the Court, FSHC and Borough professionals and once authorized by Judge Miller could be made available to the public.
