Borough Council Regular Meeting MINUTES

August 12, 2019

CALL TO ORDER

Council President Karner called the meeting to order at 7:00 p.m. at the Far Hills Municipal Building and read the open public meetings statement in accordance with the law.

REPORTS

Councilwoman Tweedie - Health/Sanitation

Councilwoman Tweedie stated that the video surveillance was completed and pending the submission of the final report by the Borough Environmental Engineer, the necessary repairs would be scheduled.

Councilman Carty - Finance/Insurance

No report.

Councilwoman Chimenti - Laws, Ordinances & Elections

Councilwoman Chimenti reported the Municipal Court deposits for July 2019 totaled \$5,389.00.

Council President Karner – Police

Council President Karner provided an update on the PBA negotiations indicating that a meeting originally scheduled for this evening had to be rescheduled. He indicated that he has also been in contact with Bedminster Mayor, Lawrence F. Jacobs, regarding the status of their PBA negotiations.

He noted that representatives from Miles for Matheny have requested to utilize the J. Malcolm Belcher Fairground on June 13, 2020 and would be providing the necessary documentation to secure that date.

Lastly, Council President Karner provided an update on the drainage issues affecting the properties along Dumont Road and DeMun Place, noting that the Borough Engineer, Ferriero Engineering had requested quotations from several contractors. Pending the receipt of the quotations, the Borough Council would make a determination regarding the project.

Chief DeCarolis

Chief DeCarolis provided details on the closure of Douglas Road and resulting detour due to the road improvements project. He also updated the Council on the installation of the "No Parking" signs along Peapack Road

Mr. Sordillo provided a brief overview of the ordinance detailing that it would allow for a limited, temporary use without the requirement to submit a formal application to the Planning Board.

There were no comments from the public. Clerk Hicks advised that the notice of the public hearing was published in the newspaper of record, and that no communication, either written or verbal, was received regarding the Ordinance.

DISCUSSION

Medical Marijuana Dispensaries

Mr. Sordillo informed the Borough Council that an individual recently contacted several municipalities, including Far Hills, inquiring about the potential for a medical marijuana dispensary and provided a brief overview of the state procedures. Mr. Sordillo clarified that this was only for medical marijuana as recreational marijuana was currently illegal in the State of New Jersey.

He also indicated that Mayor Vallone had expressed at prior Council meetings that he would not be in support of medical dispensaries in the Borough.

A general discussion ensued, resulting in Mr. Sordillo being directed to conduct further research and to draft an ordinance for further review by the Council, to potentially prohibit marijuana use in the Borough.

Mr. Rick Rinzler, 11 Hurlingham Club Road, Far Hills inquired since the Borough of Far Hills currently prohibits the sale of alcohol, could a similar ordinance be adopted for marijuana use.

Vintage Fair Event Proposal

Ms. Hicks provided a brief overview of an inquiry from Brilliant Conventions, LLC for a vintage fair event at the J. Malcolm Belcher Fairgrounds on September 21, 2019. Ms. Hicks advised the Borough Council that that date coincided with the donation collection period for the VNA Rummage Sale. Mr. Sordillo commented that he spoke with Mayor Vallone regarding this proposal, who also felt that the event was in conflict with the VNA Rummage Sale. A brief discussion ensued resulting in a general consensus that the Borough Council would not be in favor of this proposed event due to the conflict with the VNA Rummage Sale.

PUBLIC COMMENT – The Mayor and Council welcome comments from any member of the public. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers shall limit their comments to 5 minutes.

Ms. Johanna McCarten, 38 Peapack Road, Far Hills provided additional details on the process of obtaining the medical marijuana card and the limited locations of dispensaries in the area. She also inquired as to approval for the use of alcohol at the fairgrounds during the VNA Sale.

Council President Karner responded that only beer and wine was permitted and was a one-time use for the VNA appreciation luncheon for their volunteers.

Ms. McCarten also commented that loud music began at 6:00 a.m. at recent events held at the Fairgrounds.

It was suggested that noise controls be included in the application process for future events.

There were no further comments from the public.

ADJOURNMENT

Motion by Councilwoman Tweedie, seconded by Councilman Carty and unanimously carried to adjourn the meeting at 7:31 p.m.
