DISCUSSION

Special Use Permit – Far Hills Race Meeting

Attorney Sordillo provided an overview of the new application process for the telecommunications companies to install temporary cellular towers at the Far Hills Race Meet event via a Special Use Permit in accordance with Ordinance 2019-05. He proposed a five-year period for the permitted use in order to streamline the application process and advised that legally the Borough Council could authorize a permitted use for a designated period of time. He noted that should there be any changes due to location or equipment, a new application and public hearing would be required. Mr. Sordillo stated that this would be separate from the Large Event Permit application, which is required by the Far Hills Race Meet Association. A brief discussion ensued resulting in a general consensus to authorize the special use permit for a period of five years for the temporary cellular tower installation.

PUBLIC COMMENT – The Mayor and Council welcome comments from any member of the public. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers shall limit their comments to 5 minutes.

Mr. Charles Schwester, 410 Lake Road, Far Hills brought to the attention of the Borough Council proposed legislation regarding affordable housing being spearheaded by Assemblyman Jon Bramnick.

Dr. George Mellendick, 260 Lake Road, Far Hills inquired as to the schedule and next steps with regard to affordable housing for the Borough to be in compliance with the court mandated schedule. He also inquired about the scenic corridor buffer for the Errico Acres Development.

Mr. Sordillo responded by outlining the procedures and documentation required of the Borough Council and the Planning Board and provided additional details on the proposed developments. Mr. Sordillo also addressed the requirements for the scenic corridor buffer at the Errico Acres Development.

Dr. Mellendick expressed concerns regarding sufficient notice to residents and asked if, in addition to posting on the website and publication in the newspaper, other measures could be taken to ensure that residents were aware of the affordable housing presentations.

Janine Silberberg, 90 Hidden Valley Way, Far Hills inquired as the location of the affordable housing documentation on the Borough website as the information was no longer listed under Latest News.

Clerk Hicks responded by identifying the location for the Latest News Archive on the website.

Charles Schwester, 410 Lake Road, Far Hills inquired if the developers could mail residents information about their proposed development in advance of the public presentation.

There were no further comments from the public.
