MINUTES

September 23, 2019

CALL TO ORDER

Mayor Vallone called the meeting to order at 7:02 p.m. at the Far Hills Municipal Building and read the open public meetings statement in accordance with the law.

PLEDGE OF ALLEGIANCE

Mayor Vallone led the Pledge of Allegiance.

REPORTS

Councilman Hand - Fire, Water, Light, Buildings & Grounds

Councilman Hand noted that preparations were underway for the VNA Rummage Sale to be held October 4, 5 & 6, 2019.

Councilwoman Tweedie - Health/Sanitation

No report.

Councilwoman Tweedie inquired as to the status of the sewer pipe repair along Route 202. Ms. Hicks responded that the repair was completed last week. Councilwoman Tweedie indicated that since this repair has been recently completed, the Borough Environmental Engineer should be submitting the analysis report from the video surveillance in the near future.

Councilman Surks - Roads

Councilman Surks expressed appreciation to Mayor Vallone for suggesting a potential joint bid proposal for the DeMun Place/Dumont Road Drainage and Ludlow Avenue Road Improvements projects.

Councilman Surks reported that he personally reviewed Lake Road and noted that the Bedminster DPW did an excellent job completing several pothole repairs.

Councilman Carty - Finance/Insurance

Chief DeCarolis

Chief DeCarolis reported that this was the last day for the collection of donations for the VNA Rummage Sale. He also reported that paving work on Peapack Road was completed this morning.

He also stated that parishioners for St. Elizabeth's Church should disregard the "No Parking" signs along Peapack Road for church services on Saturday and Sunday.

Mayor Vallone

Mayor Vallone reported that he met with CFO, Debra Stern to review the budget for the third quarter and indicated that Council members should begin to plan for the 2020 budget.

Mayor Vallone reported that the PBA negotiations were ongoing with a conclusion anticipated in the next month.

He indicated that Somerset County had begun distributing new larger recycling cans and asked that residents to please be mindful and bring the cans back to the house after collection is completed. He noted that a resident from Pennbrook Road raised a concern as several cans were left out at the curb and had blown into the roadway.

PRESENTATION

Far Hills Race Meeting Association, Inc.

Mr. Ronald Kennedy, Chairman and Mr. Guy Torsilieri, Chairman

Mayor Vallone introduced the representatives of the Far Hills Race Meeting Association, Inc. and acknowledged that this year would mark the 99th anniversary of the event. He also stated that the Borough of Far Hills would be celebrating its 100th year anniversary in 2021.

Mr. Guy Torsilieri indicated the Race Event would be held on Saturday, October 19, 2019. He provided a brief overview of the event indicating that pari-mutuel wagering would be held again this and ticket sales continue to be strong.

Mayor Vallone commented that the event has a strong community relationships and contributes to many local organizations including Robert Wood Johnson University Hospital, opioid abuse centers and cancer support organizations. He also noted that, through the large event permit application fees, the event also contributes to the Borough.

PUBLIC HEARING - SPECIAL USE PERMIT APPLICATION

New Cingular Wireless PCS, LLC ("AT&T") - B18, L1 – 100 Liberty Corner Road, Far Hills, NJ Temporary Telecommunications Cell Site and Related Cell on Wheels Equipment

Ms. Judith A. Fairweather, Pinilis Halpern, LLP, Counsel for AT&T presented the Special Use Permit Application for the Cell on Wheels (COW) for the Race Event.

New York SMSA Limited Partnership d/b/a Verizon Wireless - B18, L1 – 100 Liberty Corner Road, Far Hills, NJ

100' Temporary Antenna Structure and Associated Telecommunications Equipment

Mr. Richard Schneider, Vogel, Chait, Collins and Schneider, PC Counsel for Verizon presented the Special Use Permit application for the Cell on Wheels (COW) for the Race Event.

Mr. Sordillo provided a brief overview of the application requirements and the request by each of the applicants for a five year permit time period. He noted that the five year permit would have a condition that there would be no substantial changes in the equipment year to year.

Councilwoman Chimenti inquired who would be responsible to ensure that there are no substantial changes in the equipment to be installed in subsequent years.

Mr. Sordillo responded that a construction permit application would still be required to be submitted each year and any changes from the prior year would be identified at that time.

Mayor Vallone opened the meeting for public comment on the applications.
