ORDINANCES – INTRODUCTION

ORDINANCE 2020-02 – AN ORDINANCE AMENDING ORDINANCE NO. 97-6, REVISING AND UPDATING THE BOROUGH'S REGULATIONS ON PARKING DURING SPECIAL LARGE AND PUBLIC EVENTS IN THE BOROUGH OF FAR HILLS

Mr. Sordillo indicated that the Municipal Prosecutor requested the removal of the imprisonment component in Ordinance 97-6 as it currently requires a court appearance for a parking violation. Mr. Sordillo further advised that with the amended ordinance, the violation would be satisfied by only the payment of the \$100.00 fine, without the need for a court appearance, which could lessen the workload and streamline Court proceedings.

ORDINANCE 2020-03 – AN ORDINANCE AMENDING AND SUPPLEMENTING THE LAND MANAGEMENT ORDINANCE OF THE BOROUGH OF FAR HILLS TO ESTABLISH A NEIGHBORHOOD OFFICE MIXED-USE AFFORDABLE HOUSING OVERLAY (NO-AHO) ZONE DISTRICT FOR THE PROPERTIES IDENTIFIED AS BLOCK 13, LOTS 2 & 3 IN THE BOROUGH OF FAR HILLS AND TO ESTABLISH USE, BULK AND DEVELOPMENT STANDARDS FOR MUNICIPALLY-SPONSORED AFFORDABLE RENTAL APARTMENT DEVELOPMENT ADDRESSING A PORTION OF FAR HILLS BOROUGH'S THIRD ROUND AFFORDABLE HOUSING OBLIGATION.

Mr. Sordillo provided a brief overview and indicated that this ordinance follows the presentation made by Mr. Hotz at the February 10, 2020 Borough Council meeting and addresses the properties at 8 and 10 Peapack Road. Mr. Sordillo further explained that Mr. Hotz would also be redeveloping the existing house at 46 Peapack Road and which redevelopment was previously authorized by Ordinance 2019-07.

Mr. Sordillo outlined the procedures and documentation required of the Borough Council and the Planning Board, indicating that Ordinance 2020-03 was planned to be presented to Planning Board for a consistency review with the Master Plan at the March 2, 2020 Planning Board meeting.

He further informed the Borough Council and public that due to a lack of a quorum, it was necessary to cancel the March 9, 2020 Borough Council meeting. The public hearing on Ordinance 2020-03 would be held at the March 23, 2020 Borough Council meeting. He further stated that Fair Share Housing Center had been apprised and a request for an extension until April 6, 2020 was submitted to the Court.

He stated that both he and Ms. Hicks have been in contact with the County in an effort to correct this error, but per the County the correction could not be made at this time due to prior submissions from other municipalities for federal funding. Mr. Sordillo advised that the Resolution was revised to include a condition that the County would make the necessary corrections to properly identify the developments in the Borough.

Rick Rinzler, 11 Hurlingham Club Road, Far Hills noted a correction to the title of Ordinance 2020-03 from "Thirst" Round to "Third" Round.

Charles Schwester, 410 Lake Road, Far Hills expressed concern regarding the negotiation for the property at 46 Peapack Road. He also inquired as to the monitoring of the occupancy limits and restrictions on the affordable housing units specifically in regard to the financial implication of additional school aged children.

Mayor Vallone responded that he regularly meets with the superintendent of the Somerset Hills Regional School District and the Borough annually reviews the school enrollment list for confirmation of residences in the Borough. He advised that the current enrollment in Far Hills was 89 students; a decrease from the prior year.

Mr. Sordillo advised that as a sending district, the Borough is invoiced on a per student basis.

Cindy Campbell, 81 Peapack Road, Far Hills inquired as to the verification process for the school enrollment list.

A general discussion ensued regarding the verification process of school enrollments within the Borough.

George Mellendick, 260 Lake Road, Far Hills expressed concern for the potential overcrowding of the affordable housing units, specifically the property at 46 Peapack Road due to the square footage of the proposed units.

Mr. Sordillo responded that applicants for affordable housing must qualify on both income and household size requirements.

There were no further comments from the public.

Motion by Councilwoman Tweedie, seconded by Councilman Hand and unanimously carried to close the meeting to public comment.
