CALL TO ORDER

Mayor Vallone called the conference call meeting to order at 7:00 p.m. and read the open public meetings statement in accordance with the law.

Councilwoman Chimenti – Laws, Ordinances, & Elections

Councilwoman Chimenti reported the Municipal Court deposits for February 2020 totaled \$7,366.00.

Council President Karner - Police

Council President Karner reported there were 2 Covid-19 related cases in the Borough and noted that they were from the same residence. He also commented that the Fairgrounds have been closed, however, that the walking track would remain open for residents use but would be monitored by the Police Department to ensure appropriate social distancing requirements were being met.

Chief DeCarolis

Chief DeCarolis acknowledged the efforts of everyone in the Police Department and the Borough Administration during these difficult times. He noted that through the efforts of the County Office of Emergency Management, appropriate personal protective equipment (PPE) was obtained for the police officers. Lastly, he informed the Council that the Police Department was on a modified operations schedule.

Mayor Vallone

Mayor Vallone commended everyone for doing such a fabulous job during these challenging times. He stated that communications with the County and State occur on a daily basis and information would continue to be updated to the Borough website, sent out via Nixle and in the local newspapers to ensure that our residents were informed. He also encouraged the public to reach out to the appropriate authority for any assistance and especially, for the small business owners to apply for financial assistance.

Mayor Vallone expressed appreciation to the many first responders for their extraordinary efforts in providing continued service to our residents, and emphasized that the safety of our employees and residents was paramount.

ORDINANCE 2020-03 – AN ORDINANCE AMENDING AND SUPPLEMENTING THE LAND MANAGEMENT ORDINANCE OF THE BOROUGH OF FAR HILLS TO ESTABLISH A NEIGHBORHOOD OFFICE MIXED-USE AFFORDABLE HOUSING OVERLAY (NO-AHO) ZONE DISTRICT FOR THE PROPERTIES IDENTIFIED AS BLOCK 13, LOTS 2 & 3 IN THE BOROUGH OF FAR HILLS AND TO ESTABLISH USE, BULK AND DEVELOPMENT STANDARDS FOR MUNICIPALLY-SPONSORED AFFORDABLE RENTAL APARTMENT DEVELOPMENT ADDRESSING A PORTION OF FAR HILLS BOROUGH'S THIRD ROUND AFFORDABLE HOUSING OBLIGATION

RESOLUTIONS

Mayor Vallone stated that the 2020 Municipal Budget had to address many new challenges due to the COVID-19 pandemic and the resulting cancellation of large events routinely held in the Borough. Additionally, Mayor Vallone stated through conversations with the Borough Tax Assessor, Ed Kerwin it was determined that there has been an overall downward shift in the assessed values of larger homes throughout the State and which has significantly affected assessments in the Borough of Far Hills.

Mayor Vallone stated this year's Budget addresses the municipal expenditures and contract obligations while maintaining one of the most competitive and lowest municipal tax rates in the County. He expressed his appreciation to Councilman Carty and Council President Karner for their time and effort serving on the Budget Committee.

Resolution 20-062 - Self Examination of Budget

Mr. Sordillo briefly reviewed the self-examination process and stated the Borough's 2020 Budget is in compliance with all applicable laws and has also been reviewed by the Borough Auditor.

PUBLIC HEARING

Comcast Corporation's Cable Franchise Renewal Application

Mr. Sordillo stated the public hearing was originally scheduled for the March 23, 2020 Borough Council meeting but, due to the cancellation of that meeting and a scheduling conflict with the Comcast representative, it was necessary to carry the public hearing to the April 27, 2020 Borough Council meeting. Mr. Sordillo briefly outlined the franchise renewal application process; submission for review by the Board of Public Utilities and the new FCC regulations regarding negotiations between the municipality and the cable provider.

PUBLIC COMMENT – The Mayor and Council welcome comments from any member of the public. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers shall limit their comments to 5 minutes.

Motion by Council President Karner, seconded by Councilwoman Tweedie and unanimously carried to open the meeting to public comment.

Rick Rinzler, 11 Hurlingham Club Road, Far Hills expressed his appreciation to the Far Hills Police Department for their continued patrol during the health crisis. He also commented about the power outage that occurred this afternoon and noted that wires were down along Route 202 at the same location as a previous incident, inquiring if that specific location was potentially problematic.

Mayor Vallone responded that he would reach out to Ms. Carol Bianchi, the Borough's JCP&L representative.

There were no further comments from the public.

Motion by Council President Karner, seconded by Councilwoman Tweedie and unanimously carried to close the meeting to public comment.

Council President Karner commented he would like two issues addressed at the next Council meeting. The first being the need for an ordinance to prohibit unauthorized parking at the municipal building parking lot and the second, requesting verification of addresses of residences in Bernardsville that were utilizing a Far Hills mailing address.

Councilwoman Chimenti commented that during the annual review of the Municipal Court by the Vicinage it was noted that there was inadequate parking on Court days and that this ordinance would assist in addressing that concern.

Mr. Sordillo responded that he has been working on the ordinance to address the parking at the municipal building lot and was currently reviewing several existing parking ordinances in order to provide a comprehensive update of the parking regulations in the Borough. He indicated that he would have the ordinance prepared for the next Borough Council meeting.

Mayor Vallone asked that Mr. Sordillo also reach out to the Borough Tax Assessor, Ed Kerwin to ascertain any address discrepancies between Bernardsville and Far Hills.
