# Councilman Hand - Fire, Water, Light, Buildings & Grounds

Councilman Hand reported that residents were utilizing the walking track at the Fairgrounds.

# Councilwoman Tweedie - Health/Sanitation

Councilwoman Tweedie commented that on social media someone posted an incident of a dog biting another dog at the Fairgrounds and asked if police officers could monitor and enforce the leash law. Chief DeCarolis responded that he was unaware of the dog incident but would increase patrol at the Fairgrounds.

### Councilman McLean - Roads

Councilman McLean reported that Borough Engineer, Paul Ferriero was reviewing the road projects for potential submission for a NJDOT grant and indicated that drainage repairs to Pennbrook Road would need to be completed prior to milling and paving Lake Road.

Mayor Vallone indicated that he had also spoken with Mr. Ferriero and agreed that repairs to Pennbrook Road should be considered for the FY2021 NJDOT grant submission.

#### Councilwoman Chimenti - Laws, Ordinances, & Elections

Councilwoman Chimenti reported that the Court session on May 12, 2020 was held via a Zoom virtual meeting and it was recommended that additional confirmation of the scheduled court times prior to the meeting should be conducted.

#### Chief DeCarolis

Chief DeCarolis informed the Borough Council of police action involving the Far Hills officers, State Police Aviation unit, and the Sheriff K-9 unit which occurred on May 12, 2020 at 2:30 a.m. in the Polo Club. Law enforcement intervened on a potential multiple vehicle theft which resulted in the arrest of two suspects. Chief DeCarolis commended all units involved but acknowledged the exemplary efforts of Officer Christopher Merkle who initially came upon the suspicious activity.

#### Mayor Vallone

Mayor Vallone acknowledged the exceptional efforts of the Far Hills Police Department and expressed his appreciation for the additional support provided by our neighboring law enforcement entities.

Mayor Vallone informed the Council of the small gathering, held on Friday, May 22, 2020 in Far Hills and Bedminster, as a remembrance of our fallen heroes on this year's Memorial Day. The event, organized by members of the Far Hills Bedminster Fire Department and First Aid Squad, was recorded and planned to be broadcast on social media. Mayor Vallone expressed his appreciation to Mr. Ron Kennedy for spearheading the ceremony.
