Mayor Vallone called the conference call meeting to order at 7:05 p.m. and read the open public meetings statement in accordance with the law.

REPORTS

Councilman Hand - Fire, Water, Light, Buildings & Grounds

No report.

Mayor Vallone inquired about the maintenance of the baseball field and requested that the area be cleared of weeds and prepared for the summer league season. Councilman Hand responded that he would reach out to Bedminster DPW Director, Mr. John Mantz.

Council President Karner stated that he was contacted by Mr. Dan McCollum, who collects the recycling at the fairgrounds, who indicated that people were disposing the dog waste bags incorrectly into the recycling bins. Councilman Hand indicated that he would look into this situation and make arrangements to have different recycling bins installed to more clearly differentiate from the trash bins.

Councilwoman Tweedie - Health/Sanitation

Councilman McLean - Roads

Councilman McLean commented that there were sections of Lake Road in need of repair and expressed concerns for the safety for bicyclists and pedestrians. He inquired as to the status of the road improvement project.

A brief discussion ensued regarding improvements to the roadway resulting in further review by the Borough Engineer and Bedminster DPW Director, John Mantz.

Council President Karner - Police

Council President Karner provided a brief overview of the request for the purchase of a new police SUV and the reallocation of capital ordinance funds.

He also reported that the Far Hills Police Department had been contacted to offer support to neighboring municipalities in light of the increase in demonstrations due to the death of George Floyd. He reaffirmed that the Far Hills Police Department remains consistent in their dedication and professionalism in serving the residents of Far Hills.

Chief DeCarolis

Chief DeCarolis indicated that Lake Road remained closed due to the installation of new gas line by PSE&G and anticipated that the work would be completed by tomorrow.

He expressed his appreciation to the Borough Council for their support regarding the purchase of a police vehicle and explained that budgeting and replacement schedule for the police vehicles. He also noted that the installation of the Watchguard Evidence Management System was underway with cameras in the police vehicles, headquarters and interview rooms.

He commented that the Far Hills Police Department was on call for mutual aid assistance with neighboring municipalities and expressed his appreciation to the Borough Council for their support of the department during these challenging times in law enforcement.

Mayor Vallone

Mayor Vallone echoed the comments made by Council President Karner with regard to the professionalism exhibited by our Police Department. He also acknowledged the leadership of Chief DeCarolis and conveyed the Borough Council's support of our officers in these difficult times.

Mayor Vallone reported that he received a call from Mr. Dan Powell, CEO VNA/Atlantic Health regarding preparations for the Rummage Sale in October 2020, and would keep the Council apprised upon review of the VNA's plans for safety and social distancing protocols for this event.

He also stated that the Essex Horse Trials scheduled for July 18-19, 2020 had been cancelled due to health and safety concerns from its sponsors; however, the Far Hills Race Meeting was currently planned to proceed on October 17, 2020.

Mayor Vallone reported that he asked Ms. Hicks to inquire into the status of the NJDOT Route 202 Bridge over the North Branch of the Raritan River project and it was determined that the construction was not expected to begin until Spring 2024. He noted that requests have also been made of the NJDOT for a public presentation regarding this project.

ORDINANCE 2020-10 – AN ORDINANCE GRANTING RENEWAL OF MUNICIPAL CONSENT TO COMCAST TO CONSTRUCT, CONNECT, OPERATE AND MAINTAIN A CABLE TELEVISION AND COMMUNICATIONS SYSTEM IN THE BOROUGH OF FAR HILLS, COUNTY OF SOMERSET, NEW JERSEY.

Mr. Sordillo provided an overview of the cable franchise renewal process with the Board of Public Utilities. He indicated that the contract negotiations provided additional services at no cost to the Borough including a public access channel, cable television service outlet(s) and a one-time technology grant of \$5,000.00.

Council President Karner inquired as to the length of the agreement. Mr. Sordillo responded that the franchise was for ten (10) years and commented that the contract lengths were now shorter due to the ever-changing technology.
