Councilman Kevin Welsh - Fire, Water, Light, Buildings & Grounds

Councilman Welsh reported the municipal building grounds were in good shape for the upcoming 100th Anniversary event on May 15th. He noted that he would be reviewing the J. Malcolm Belcher Fairgrounds and baseball field for remediation and potential improvements.

Lastly, he reported the pennants for the fairground buildings were expected to arrive this week and would hopefully be installed prior to May 15th.

Councilman McLean inquired if a Pickle Ball court could be considered for an addition to the fairgrounds.

Council President David Karner - Police

Council President Karner expressed his appreciation to the Far Hills Bedminster Fire Department for reinstalling the banner which had recently come down due to heavy winds.

Lastly, he noted that there would be a DUI police enforcement detail over the Memorial Day holiday.

Mayor Vallone

Mayor Vallone reported he spoke with Mr. Dan Powell; CEO of the Visiting Nurse Association and the rummage sale would be occurring in October 2021. Mayor Vallone reported the Far Hills Race Meeting would be held on October 16, 2021 and noted the Essex Horse Trials would be held July 17 and 18, 2021. Lastly, he informed the Council the Memorial Day Parade, organized by the Far Hills Bedminster Fire Department, would be held on Monday, May 31, 2021 beginning at 10:00 a.m.

Mayor Vallone stated the number of Covid cases in Far Hills has declined from thirteen to seven.

BUDGET 2021 - Mayor's Statement

Mayor Vallone provided an overview of the 2021 Budget and expressed his appreciation to everyone who worked so conscientiously to develop a budget that not only serves our residents but is also fiscally responsible. Mayor Vallone stated that the Borough of Far Hills is one of only a few municipalities that is debt free. He stated that the 2021 municipal tax rate would increase by 1.13% and commented the Borough of Far Hills municipal tax rate remains one of the lowest in the state of NJ. Mayor Vallone also reported property value assessments were slightly decreased this year by 0.34%. Lastly, he stated that due to the inability to hold many large events in 2020, the Borough sustained a loss of approximately \$100,000.00 in revenue.

Borough Auditor, Kathryn Mantell of Nisivoccia, LLC concurred with the budget statements made by Mayor Vallone. She also acknowledged the proactive efforts made by both Mayor Vallone and CFO Debra Stern regarding the development of the 2021 budget. She briefly reviewed her projections for this year's current fund, anticipated surplus and the sewer utility budget and commented that the increase in this year's municipal tax rate was very modest.

Council President Karner inquired as to the decrease in the property value assessments. Ms. Mantell stated assessments were typically under the purview of the Borough Tax Assessor but opined that the decrease in assessments was likely due to the economy.

George Mellendick, 260 Lake Road, Far Hills concurred with the comments made by Mr. Schwester. Dr. Mellendick also inquired about the permitting requirements for realtor signs.
