# Councilwoman Mary Chimenti - Laws, Ordinances, & Elections

Councilwoman Chimenti reported the Municipal Court deposits for the month of May 2021 totaled \$2,485.88.

## Council President David Karner - Police

Council President commented there were several people picnicking at the fairgrounds this past weekend and one individual had set up an inflatable pool which was presumably filled with buckets of water from the Raritan River. He noted that several people were also sitting in chairs in the river and expressed concern for potential liability issues for the Borough. He suggested a review of the Borough's ordinances regarding parking and permitted uses of the fairgrounds.

A brief discussion ensued regarding the maintenance of the ballfield at the fairgrounds. Mayor Vallone indicated that Somerset County has been contacted regarding undertaking this project due to limited staffing within the Bedminster DPW.

#### Chief Michael DeCarolis

Chief DeCarolis indicated Detective Merkle would be returning to the Far Hills Police Department after a six-month assignment with the Somerset County Prosecutor's Office. He noted that officers would also review the fairgrounds and ensure that all applicable ordinances were enforced.

### Mayor Paul J. Vallone, MD

Mayor Vallone provided an overview of the upcoming Essex Horse Trials event which is scheduled for July 16, 17 & 18, 2021 at Moorland Farm.

He noted the VNA Rummage Sale and the Far Hills Race Meeting were planned to proceed this year.

Ms. Hicks added that while Bernards Township was providing the engineering and contract oversight, the Borough of Far Hills, as the recipient of the NJDOT Local Aid grant was procedurally responsible for the appropriation of the funds. After the allocation of the grant funds, the project costs would be shared equally between Bernards Township and the Borough of Far Hills. It was noted that Bernards Township was providing the engineering and contract oversight at no cost to the Borough of Far Hills.

Borough Auditor, Kathryn Mantell of Nisivoccia, LLC provided an overview of the 2020 Audit. She explained it was necessary to replace two pages (E and C-5) in the bound books due to a typographical error and offered to provide new audit books to the Borough. Ms. Mantell commented that the only recommendation in the Audit pertained to the segregation of duties which was reflected in the Corrective Action Plan. It was noted that due to the limited number of staff in the Borough, this recommendation had also occurred in prior year audits.

Council President Karner inquired if there could be any cost savings by reducing the quantity of the bound books currently provided to the Borough. Ms. Mantell responded that the Borough is not charged for these books, but she could reduce the number of bound books and provide the Mayor and Council an electronic copy in the future. There was a general consensus to reduce the number of bound books in favor of receiving an electronic copy of next year's audit for the Mayor and Council.

# Antique Car Show - J. Malcolm Belcher Fairgrounds

Mayor Vallone provided an overview of an application submitted for the use of the fairgrounds for an antique car show on October 23, 2021. A general discussion ensued resulting in an overall consensus to decline the event due to the number of large events already scheduled for October in Far Hills and an additional event could be burdensome to the residents.

**PUBLIC COMMENT** — The Mayor and Council welcome comments from any member of the public. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers shall limit their comments to 5 minutes.

Ms. Hicks informed members of the public that the Borough Council would be adhering to the five-minute time limit for public comment. Members of the public would be advised when one minute remained; and again when thirty seconds remained.

Motion by Council President Karner, seconded by Councilwoman Chimenti, was unanimously carried to open the meeting to public comment.

George Mellendick, 260 Lake Road, Far Hills inquired if the public would be provided with an agenda for the presentation by the developer for the Residences at Overleigh, scheduled for the July 5, 2021 Planning Board meeting. He also inquired as to the process for public comment during this presentation.

Mr. Sordillo responded the agenda for the presentation was at the discretion of the developer. He also provided a brief overview of the process for public comment and questioning of witnesses during a Planning Board public hearing.

Jack Koury, Far Hills Avenue, Far Hills expressed his appreciation to the Borough Council for denying the application for an antique car show at the fairgrounds. He also suggested additional signage indicating that dogs must be on a leash should be posted at the fairgrounds.

Council President Karner suggested a review of the current signage as well as the rules for the use of the fairgrounds and agreed to coordinate this effort with Councilman Welsh.

There were no further comments from the public.

Motion by Council President Karner, seconded by Councilwoman Tweedie, was unanimously carried to close the meeting to public comment.
