Councilman Kevin Welsh - Fire, Water, Light, Buildings & Grounds

Councilman Welsh reported the NJDOT would be removing the tree and branch debris collecting under the Route 202/North Branch of the Raritan River bridge. He acknowledged the efforts of Ms. Hicks for coordinating this remediation.

Councilman Ted McLean - Roads

Councilman McLean reported Somerset County has completed the cleaning and jetting of the stormwater inlets throughout the Borough. The County had also submitted an estimate of \$4,000.00 for repairs to damaged guide rails along Lake Road. Lastly, he informed the Council the Borough has received a NJDOT Local Aid FY 2022 grant in the amount of \$209,510.00 for improvements to Dumont Road and DeMun Place.

Council President David Karner - Police

Council President Karner reported that after interviewing several candidates for the position of Police Officer a highly qualified candidate was selected and would be appointed this evening. Council President Karner acknowledged the efforts of Mr. Jack Koury who informed the Borough of a water leak on Far Hills Avenue and Schley Road. New Jersey American Water was contacted and the issue was being investigated.

Chief Michael DeCarolis

Chief DeCarolis apprised the Council of an increase in car thefts in the area and reminded residents to remove valuables from their cars and to lock their doors and garages every day.

Mayor Paul J. Vallone, MD

Mayor Vallone expressed his appreciation to the Far Hills Police Department and recognized that residents must take an active part to thwart these crimes by locking their cars and homes.

He also thanked Council President Karner and Councilman Carty for their time and dedication through the interview process and the selection of our new police officer.

Mr. Sordillo responded that the Recreation Committee was solely an advisory committee and had no authority to spend funds. He explained the use of this payment to the Borough was detailed in the affordable housing agreement with Melillo Equities and funding was allocated for improvements to public amenities and enhancement of the Fairgrounds and Far Hills Village area. Mr. Sordillo further clarified that any expenditure of these funds would need to be authorized by the Borough Council.
