MAYOR'S ADDRESS

Dear Members of the Borough Council, Distinguished Guests, Neighbors and Friends:

As I begin my 12th year as your Mayor, it is customary, and it is my privilege to give the State of the Borough Address. 2021 has certainly been challenging for our families and friends, not only here in Far Hills, but around the country and the world. Covid, with the Delta variant and now the Omicron

variant has changed the way we work, play, and interact in almost every facet of our lives. I hope, as we all do, that 2022 brings more normalcy and health to all those around us.

Despite these challenges, we have worked with the State Health Department and advisors from Trenton and have taken every possible precaution to ensure the safety of our residents and our employees here at the Municipal Building. To that end, I have made the decision to continue to hold all municipal public meetings via Zoom for the foreseeable future, until we can clearly see an improvement in community health and a decline in Omicron infections.

Despite these challenges, I, the Borough Council, the Planning Board and Board of Health have worked diligently on your behalf. Our COAH obligations which have been approved by the Court have been addressed and will soon be completed. I thank the Planning Board for their diligence and hard work toward this end.

On the very positive side, Far Hills continues to be fiscally sound and continues to have some of the lowest municipal taxes in the state of New Jersey. We will continue to utilize share services with our neighbors to ensure the lowest cost of goods and services to our residents. We have over the years, improved many roads, and will continue to work hard to obtain grants wherever possible. The latest example is Mine Brook Road where we utilized a NJDOT grant and collaborated with our neighbors in Bernards Township.

This year, we had all 180 catch basins around the Borough cleaned out and over eighteen tons of debris has been removed to improve drainage and help reduce flooding.

We have, and always do our absolute best to ensure the safety of our residents. Our Chief of Police, Chief DeCarolis and his team do an excellent job and yes, we support our police and thank them for their service. This year, we welcomed two new officers to replace two officers that have retired or moved on.

Our Recreation Committee will continue to work on restoring the Fairgrounds to its former glory with structural and aesthetic improvements for the enjoyment of all our residents. Work has already begun, so stay tuned. To that end, my wife Janis and I have donated a 16-foot Blue Spruce tree planted by the flagpole on the Fairgrounds. This will start a new annual tradition with the holiday tree lighting in Far Hills and will take place this December 3, 2022, so please plan to attend with your friends and families. In addition, seasonal activities throughout the year will take place as well for our residents to enjoy!

To Dorothy Hicks, and her administrative team, thank you for managing the day-to-day municipal operations and despite Covid-19 providing excellent service to our residents. I also want to thank Judge Adler, Marjorie Freeman, Councilwoman Chimenti and the staff of our municipal court for their great work and adapting to the many changes required of them this year.

To our professional team, our attorneys, planners, engineers, zoning, and construction officials, thank you for your dedication to professional excellence and always putting Far Hills first.

So, as we begin 2022, I wish you and your families a healthy, happy, and prosperous New Year. And know that together we have achieved much and as Mayor, I and your Borough Council have and will always do what is in the best interest of Far Hills and all its residents. I thank you for your continued support.
