CALL TO ORDER

Council President Karner called the remote meeting to order at 7:05 p.m. and read the open public meetings statement in accordance with the law.

REPORTS

Councilwoman Tweedie - Health/Sanitation

Councilwoman Tweedie reported the Borough's Environmental Engineer, Natural Systems Utilities (NSU) would be jetting the sewer system in July. She cautioned that the jetting process had the potential to force water and air bubbles back in the property owner's plumbing which could allow sewer gases to enter the house. It is important that the toilets have an adequate amount of water in the bowl and P-trap to block these gases. Residents in the Village and the Polo Club will be provided notification through Nixle, the Borough website and also via an insert in the upcoming tax bill mailing but word of mouth was also encouraged. NSU would also be sending letters and going door to door to all affected residents prior to the commencement of the jetting of the sewer system.

Councilman Joseph Carty - Finance/Insurance

Councilwoman Chimenti - Laws, Ordinances & Elections

No report. Councilwoman Chimenti noted that one sash from the Memorial Day Parade had still not been returned and stated she gave her sash to Officer Jenkins and asked Ms. Hicks to confirm that it was received.

Council President Karner - Police

Council President Karner acknowledged the efforts of Detective Corporal Kamieniecki and Officer Minardi in assisting the Peapack & Gladstone Police Department to locate a missing person.

He indicated that a car was stolen from the Far Hills Train Station on June 24, 2022 and it was reported to have been unlocked and left running. Residents were again reminded to lock their vehicles and homes to avoid becoming a victim of theft.

Lastly, he noted Chief DeCarolis was not available this evening due to his attendance at the Police Security Conference in Atlantic City this week.

PUBLIC COMMENT — The Mayor and Council welcome comments from any member of the public. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers shall limit their comments to 5 minutes.

Motion by Councilwoman Chimenti, seconded by Councilwoman Tweedie to open the meeting to public comment.

Charles Schwester, 410 Lake Road, Far Hills stated he informed Chief DeCarolis that the directional sign on Lake Road had been damaged due to a vehicular accident. Ms. Hicks was asked to also reach out to the Bedminster DPW and/or Somerset County regarding replacing the signage.

Mr. Schwester opined that the increase in interest rates would have an adverse effect upon real estate in the Borough and specifically raised concerns as to the viability of the Pulte/Residences at Overleigh development. He also reiterated his comments from the June 13, 2022 Borough Council meeting regarding changes to the NJDEP emergency floodplain regulations as well as the status of his request to be provided a financial impact study for the development.

Council President Karner thanked Mr. Schwester for his comments and responded he would meet with Mayor Vallone, Councilman Carty, and Mr. Sordillo to review these concerns and any effect they may have to the Pulte/Residences at Overleigh development that could be detrimental to the Borough.

Mr. Schwester was notified that he had exceeded the five-minute limit but was granted an additional two minutes by Council President Karner. After a lengthy heated discussion, Ms. Hicks was asked to mute Mr. Schwester's microphone for the remainder of the public comment portion of the meeting.

There were no further comments from the public.

Motion by Councilwoman Tweedie, seconded by Councilwoman Chimenti to close the meeting to public comment.

A brief discussion ensued resulting in Ms. Hicks being directed to share this information with Mayor Vallone.
