# IN PERSON MEETING AT MUNICIPAL BUILDING

### **CALL TO ORDER**

Mayor Karner called the meeting to order at 7:01 p.m. and read the open public meetings statement in accordance with the law.

### **PRESENTATION**

# Special Recognition of Detective Christopher Merkle and Officer Thomas Finnerty, Jr.

Councilmen Rinzler and Carty acknowledged the exceptional efforts of both Detective Merkle and Officer Finnerty.

Chief DeCarolis presented Officer Thomas Finnerty, Jr. with the Life Saving Award in recognition of his quick action performing CPR and the use of a defibrillator to successfully resuscitate an individual while on vacation in South Carolina. Officer Finnerty's son, Thomas Finnerty, III, also a police officer assisted in these lifesaving efforts.

Chief DeCarolis presented Detective Christopher Merkle with the Meritorious Service Award in recognition of his work in securing the arrest of suspects linked to burglary, theft, and human trafficking at Natirar Park. Councilman Rinzler read a letter from Peapack and Gladstone's Chief of Police which expressed appreciation to Detective Merkle for his extraordinary efforts and assistance with the apprehension of these suspects.

Mayor Karner extended his appreciation and expressed pride in having such a fine and dedicated police force in the Borough of Far Hills.

#### REPORTS

## Councilwoman Tweedie - Health/Sanitation

Councilwoman Tweedie reported she attended the Sanitary Transmission Advisory Board (STAB) meeting on October 13, 2022 and unfortunately, there was no update regarding the federal grant funding and the Somerset County grant funding has not yet been received.

## Councilman McLean - Roads

Councilman McLean provided an overview of the Pennbrook Road Improvements project as well as the bids received and the necessary capital appropriations.

# Councilwoman Chimenti - Laws, Ordinances & Elections

Councilwoman Chimenti reported she would be meeting with Judge Katty Wong-Taylor following the court session on October 25, 2022 to review when in-person sessions would resume in the Borough.

### Councilman Rinzler - Police

Councilman Rinzler reported there were minimal police incidents during the Far Hills Race event which occurred on October 15, 2022. He also noted that the surrounding neighborhoods were free from trash and debris which had been an issue with prior events.

# **Mayor Karner**

Mayor Karner stated the Far Hills Race event was held on a beautiful day and expressed his appreciation to the Far Hills Police Department, Somerset County Prosecutor's office, the Far Hills Bedminster Fire Department, and the Far Hills Bedminster First Aid Squad. He also noted sponsors Peapack & Gladstone Bank and Open Road Auto Group as well as the National Steeplechase Association each of which contributed to a successful event. Lastly, he acknowledged the collaborative efforts of the Far Hills Race Association leadership, Messrs. Guy Torsilieri and Ron Kennedy.

He continued to report on the Atlantic Visiting Nurse (AVN) Association Rummage Sale which occurred on October 7-9, 2022 and was also a successful event. He acknowledged the efforts of Ms. Katie Dooley and Ms. Patricia Neill who co-chair the event plus the hundreds of volunteers who so graciously help support the event each year. He continued by reporting Council President Welsh had reviewed the track and fairgrounds following the event and the AVN was making all the necessary repairs.

Mayor Karner apprised the Council of the restoration efforts being undertaken by the AVN to the two barns at the J. Malcolm Belcher Fairgrounds.

Mayor Karner provided an update on the Request for Proposals for the Fiscal/Financial Impact Assessment and indicated that only one proposal had been submitted so far. It was noted the due date for submissions was October 28, 2022. He indicated a meeting would be scheduled with The Otteau Group as well as any additional responding firms to review the statement of work prior to making a final determination.

He stated in early November, young adults from the Matheny Medical and Education Center would be moving into the Matheny Group Home, located along Peapack Road, and encouraged resident to welcome them to Far Hills.

Mayor Karner indicated that CFO Debra Stern has returned from her leave of absence and expressed appreciation to the administration staff for their efforts in providing the necessary services to residents during her absence. He also offered his apologies to Councilman Rinzler for inadvertently omitting an acknowledgment of his appointment to Borough Council in Fall 2022 Newsletter.

Lastly, he informed the public of the 24% state-imposed increase in the health benefit plan premiums which would adversely affect employees and municipalities. He encouraged staff and residents to voice their concerns to their state representatives.

Motion by Councilman Rinzler, seconded by Councilman Carty to open the meeting to public comment.

Charles Schwester, 410 Lake Road, Far Hills expressed his displeasure with the campaign efforts of Mr. Mark Melillo, who was running for the Mayor of Bernardsville, and the utilization of a sticker on covering part of the front page of the Bernardsville News. He also commended the Borough Council for proceeding with the request for proposal for the financial impact study and opined that The Otteau Group was a highly qualified firm.

Dr. George Mellendick, 260 Lake Road, Far Hills inquired about the review and contractor selection for the Pennbrook Road Improvements project and expressed concern regarding maintaining the character of the road. He also commented upon the lack of response to the request for proposals for the financial impact study.

Mr. Sordillo responded by providing a brief overview of the Local Public Contracts Law which requires a municipality to award to the lowest responsive and responsible bidder. He also noted the Borough Engineer, Ferriero Engineering prepared the bid specifications for the Pennbrook Road Improvements project. Additionally, he provided a brief overview of the RFP process utilized for the financial impact study.

Mr. Don Hewitt, 23 Dumont Road, Far Hills requested members of the Borough Council speak directly into the microphone as he was having difficulty hearing them.

Mayor Karner acknowledged Mr. Vogel for his comments made at the October 11, 2022 Borough Council meeting regarding the history of public meetings and the importance of public participation.

There were no further comments from the public.
