CALL TO ORDER

Mayor Karner called the meeting to order at 7:00 p.m. and read the open public meetings statement in accordance with the law.

REPORTS

Council President Welsh - Fire, Water, Light, Buildings & Grounds

Council President Welsh reported progress remains steady on the repairs and painting of the two barn buildings at the J. Malcolm Belcher Fairgrounds. He acknowledged the Atlantic Visiting Nurse Association (AVN) for their contribution to these efforts and noted that there would be no cost to Far Hills taxpayers for these restorations.

He encouraged everyone to attend the first annual Holiday Tree Lighting Event which was scheduled for Saturday, December 3, 2022 at 6:00 p.m. The event is free to the public and will be held rain or shine.

Lastly, he stated two new boilers were installed at the municipal building which was made possible through a PSE&G grant and thanked Ms. Hicks for her efforts in attaining this grant.

He stated the Veterans Day ceremony was held on November 11, 2022 at the monument at the corner of Peapack Road and Prospect Street. Several residents along with members of the Far Hills Police Department and the Far Hills Bedminster Fire Department were in attendance to honor our veterans. Monsignor Edward C. Puleo of St. Elizabeth and St. Brigid Parish offered a prayer during the ceremony.

Mayor Karner thanked Council President Welsh for installing the lights on the holiday tree and encouraged everyone to attend the event on Saturday, December 3, 2022.

He continued by stating the Borough Council would be awarding a professional services contract at the November 28, 2022 meeting to The Otteau Group to conduct the Fiscal/Financial Impact Assessment on the Residences at Overleigh (Errico Acres) development.

Lastly, he welcomed Attorney Mike Silbert who was filling in for Borough Attorney, Joseph Sordillo this evening.

ORDINANCE 2022-09 AN ORDINANCE APPROPRIATING \$365,485.00 FOR CAPITAL IMPROVEMENTS – PENNBROOK ROAD – (Station 0+00 to 16+50)

Motion by Councilman Rinzler, seconded by Council President Welsh to open the meeting to the public.

Dr. George Mellendick, 260 Lake Road, Far Hills expressed concern regarding maintaining the character and the current undulations along Pennbrook Road.

A brief discussion ensued regarding the drainage and paving for this project and the potential impact upon the undulating sections of the roadway. These undulations were commonly referred to as "Jacob's Ladder" or "Thank you Ma'ams" and were used to provide an area to slow down the horse drawn carriages. There was a general consensus to approve the adoption of the ordinance contingent upon confirmation the topography would remain as close as possible to the existing roadway at the completion of the improvements. The Borough Engineer, Ferriero Engineering would be consulted to address this concern.

A brief discussion ensued resulting in Chief DeCarolis being directed to review the parking regulations on Peapack Road with the Somerset County Road Department. Mayor Karner stated he would reach out to representatives from Matheny to address the parking concerns to ensure appropriate public safety measures were implemented.

Mr. Hewitt also inquired as to the rent being charged in the new lease for the Butler's Pantry Trackside Restaurant.

Councilman Carty responded the current rent was approximately \$2,000.00 and the lease stipulated a 2% annual increase.
