MINUTES

December 12, 2022

CALL TO ORDER

Mayor Karner called the meeting to order at 7:00 p.m. and read the open public meetings statement in accordance with the law.

PLEDGE OF ALLEGIANCE

RECOGNITION

Marilyn Layton – Board of Health Chairwoman

Mayor Karner presented Ms. Marilyn Layton with a distinguished service award to recognize her nineteen years of service on the Far Hills Board of Health. Ms. Layton has also served for many years as the Chairwoman of the Board and will be stepping down at the end of her term, expiring December 31, 2022. The Mayor and Council, as well as members of the public, showed their appreciation to Ms. Layton through a round of applause.

Ms. Layton expressed her appreciation to the Mayor and Council and stated it has been her distinct pleasure to serve our community.

PRESENTATION

Ms. Aimee Hunnewell, Chief Development Officer, Matheny School and Hospital provided an overview of the Miles for Matheny event planned for June 3, 2023 and indicated a large event permit application has been submitted to Ms. Hicks for the use of the J. Malcolm Belcher Fairgrounds. The event would include a wheelchair walk, cycling event and a 5K race and an anticipated attendance of approximately 500. It was noted that there was no rain date scheduled.

A brief discussion ensued regarding the submission of the necessary permit applications within the specified time parameters.

Mr. Jack Koury commented the music from the DJ at last year's event made it difficult to hear the bag pipe musician.

Ms. Hunnewell thanked the Mayor and Council for their support of the Miles for Matheny event and left the meeting at this time.

REPORTS

Council President Welsh - Fire, Water, Light, Buildings & Grounds

Council President Welsh reported the Holiday Tree Lighting event held on Saturday, December 3, 2022 at 6:00 p.m. was well received by the community with approximately 150 attending. He acknowledged Butler's Pantry Trackside and the Far Hills Café for donating the refreshments; the Madrigals Chorus from Bernards High School for the holiday music; and the Far Hills Garden Club for the installation of the luminaries. Lastly, he acknowledged the efforts of the Recreation Committee, the Far Hills Bedminster Fire Department, Far Hills Bedminster First Aid Squad, and the many volunteers.

He also reported the Bedminster DPW would be trimming overgrown brush and removing several decaying and hazardous trees at the fairgrounds.

Councilwoman Tweedie - Health/Sanitation

Councilwoman Tweedie reported a meeting of the Sanitary Transmission Advisory Board (STAB) was planned for December 19, 2022 in the Borough of Peapack & Gladstone. She stated information on the status of the grant funding was still pending.

He apprised the Council of a meeting held on December 2, 2022 with representatives of NJ Transit to review the renewal of the lease agreement with further details to be discussed during Executive Session. He also stated the lease with the Butler's Pantry Trackside Restaurant has been finalized.

Mayor Karner provided a brief update regarding the financial assessment study for the affordable housing development and stated a special meeting was held on December 1, 2022 to award the contract to the Otteau Group, LLC. He also noted Planning Board escrow accounts were reviewed and notification was made to each applicant with a current deficiency.

Mayor Karner informed the Council of the Somerset County Commissioners Reorganization meeting which would be held on January 6, 2023 at 3:00 p.m. at Raritan Valley Community College.

Lastly, he reported there were currently two Covid cases in the Borough offices.
