CALL TO ORDER

Mayor Welsh called the meeting to order at 7:01 p.m. at the Far Hills Municipal Building and read the open public meetings statement in accordance with the law.

REPORTS

Councilman Cocoziello - Roads

Councilman Cocoziello reported the Pennbrook Road project has been delayed due to the required relocation of the PSE&G gas main lines.

Councilwoman Tweedie – Health/Sanitation

Councilwoman Tweedie reported the maintenance of the sewer system is ongoing.

Councilman Carty - Finance/Insurance

Council President Chimenti - Laws, Ordinances & Elections

Council President Chimenti reported in an effort to streamline the court proceedings, sessions would alternate between in-person and remote.

Councilman Karner - Fire, Water, Light, Buildings & Grounds

Councilman Karner reported donations were currently being collected in preparation for the Atlantic Visiting Nurse Rummage Sale scheduled to commence on May 5, 2023.

He provided an update on improvements to the fairgrounds indicating a proposal was received for repairs to the basketball court as well as installing a four-foot area asphalt around the cooking pavilion and gazebo to help remediate muddy conditions. He also reported that the Bedminster DPW have removed the dead tree adjacent to the river.

Councilman Rinzler - Police

Councilman Rinzler presented the March 2023 Police Report. He also informed the Council that an offer has been extended to a candidate for the police officer position.

Mayor Welsh

Mayor Welsh reported the 72nd annual Easter Egg Hunt held on Saturday, April 8, 2023 at J. Malcolm Belcher Fairgrounds was a success and featured over 2700 eggs. He acknowledged the efforts of the Far Hills Bedminster Fire Department and the many volunteers who worked so diligently on this event.

He stated he and Councilman Cocoziello attended a meeting on March 28, 2023 with representatives from the NJDOT regarding the Route 202 over the Raritan River Bridge Replacement project. He noted that the Borough's concerns regarding the aesthetics of the bridge were discussed. The bridge would be replaced in three phases with work planned to commence in the summer of 2025. Plans were being discussed for the coordination of emergency services during the closure of the bridge phase. Mayor Welsh stated he also requested that the NJDOT hold a public meeting to provide residents an opportunity to ask any questions.

RESOLUTIONS

Resolution 23-073 - Introduction of Municipal Budget for 2023

Mayor Welsh provided an overview of the 2023 Municipal Budget stating that the public hearing and adoption would take place at the May 8, 2023 Borough Council meeting where both the Borough Auditor, Kathryn Mantell, Nisivoccia and the Borough CFO, Debra Stern would be present.

Mayor Welsh stated the 2023 municipal tax rate of 0.520 would remain unchanged from 2022 and continues to be one of the lowest municipal tax rates in the state.

He indicated there was a 23% increase in the health insurance premiums imposed on the municipalities and their employees enrolled in the state health insurance plan, as opposed to only a 6% increase to for the state and its employees.

Mayor Welsh also noted that there was a 21% increase in police vehicle maintenance as well as overall increases in fuel and ammunition costs.

He expressed his appreciation to Borough CFO, Debra Stern for her hard work and dedication in the preparation of the 2023 budget.

Lastly, he and the Borough Council are proud to report that the Borough of Far Hills continues to be debt free.

Karen Reilly, 7 Fox Hunt Court, Far Hills inquired as to why the police vehicles had to remain idling while in the municipal parking lot.

Councilman Karner responded due to the computer and specific safety equipment in the vehicles it was necessary to keep them running.
