MAYOR'S ADDRESS

Dear Members of the Borough Council, Distinguished Guests, Friends, and Neighbors:

I am deeply honored, and it has been my privilege to serve as Mayor of Far Hills for 2023. It has been a busy year and one I am proud to have led.

I would like to take a moment to thank my beautiful wife, Ashley, of 18 years. I would also like to thank my 3 girls for their support as well. My family has supported me from the beginning, and I thank them for their continued support.

I would also like to thank our Borough Council for their many hours of dedicated service to our community. Their hard work and support is incredibly inspiring and appreciated.

2023 has been busy for our infrastructure and roads department. We have been working hard to put together a 5-year road and infrastructure improvement plan. We, as your Mayor and Council, recognize the need for this 5-year plan. We will continue to leverage grant opportunities from the NJDOT and beyond. Last year, we finished the lower section of Pennbrook Road. We received a grant for the upper section. We anticipate completing Pennbrook in 2024. In 2023, we paved the back section of Lake Road from the lake to the split. We received a grant from the NJDOT for the front section of Lake Road. We anticipate that section to be paved with drainage improvements in 2025. We also have in the queue paving and drainage improvements for Dumont Road and DeMun Place. This work should be completed in early 2024. A NJDOT grant is leveraged for this project as well. I want to thank Councilman Cocoziello for his hard work on these projects in 2023.

Pedestrian safety has been at the forefront of my mind since I took office. We have worked with Somerset County and NJDOT for a grant opportunity to improve the walkability and safety of Peapack Road. We received a grant to install crosswalk improvements at two intersections, Dumont Rd and Railroad Ave. This will consist of push-to-cross blinking signs. We anticipate the installation of these improvements shortly. We are working with vendors to perform the work as we speak.

I would like to thank our Council for their diligence earlier this year when we took a hard look at the final agreement for the Errico Acres site. We took the builder back to the table and removed the 6.9-million-dollar contribution for the age restriction set by the prior administration. This move protected the town from long-term debt, and I thank the Council for their tireless work to get to the finish line on this deal. As an inclusionary affordable housing development, we will find practical solutions as we

work through the installation of this development while protecting our neighbors during the process and holding the builder to our high standard.

On the topic of affordable housing, we have our next round just around the corner, our 2025 round is coming up, and will be active over the upcoming year as we work towards our solutions to meet our obligations to fair share. There still are a lot of unanswered questions as to the number of affordable housing units we will need to provide. This is a fluid issue, and an update will follow over this year.

This past Fall, the Atlantic Visiting Nurse rummage sale held its 100^{th} year sale. Such a remarkable event which brings excellent bargains to those who shop the event and raises money for servicing communities in our area. The Borough is happy to partner with the AVN as we continue this tradition. I have always believed in bringing the community together. Over the past year, we promoted several community events. This past year, the Far Hills Recreation Committee has put together three events. Two movie nights at the park and the Holiday Tree lighting event. I would like to thank the Recreation Committee, the volunteers, and local sponsors who supported these events. All said and done, hundreds of residents enjoyed time together as a community, and I am very proud to have witnessed these extraordinary events take shape. Small-town living, small-town values.

In the years ahead, we will face many obstacles, such as finishing the third round of affordable housing with the fourth round of affordable housing just around the corner in 2025, the US Route 202 bridge replacement projected for the summer of 2025, infrastructure and road projects, PBA contract, increasing costs across the board and many other unknowns that may turn up over the years. I am confident our Borough Council is up to the challenges we will face as we look forward into 2024.

I would like to invite residents to join us at our next Council meeting on January 22, 2024 at 7:00 pm. Please join us as we review last year's challenges and successes. We are open to public input on how we can better serve our community in 2024. I am calling this the "Community Check-in Meeting." Topics such as our 5-year infrastructure plan, improvements to the Fairgrounds, community events, etc. I want all of us to feel comfortable expressing our thoughts heading into 2024 and work together to reach our common goals.

We are all in a partnership as we move into 2024. We have a great team. A great Borough Council, Planning Board, Board of Health, Board Professionals, our competent Borough Clerk Dorothy Hicks, incredible CFO Debra Stern, and our great Municipal Court. We are all ready to do the job. I once again thank you for the opportunity to lead our community as Mayor.

Councilman Schwester objected to the appointment of Sheila Tweedie to the Planning Board as a Class IV member for a four-year term. Councilmen Carty and Rinzler also supported a change in this appointment and expressed a need for new members on the Planning Board.

Mayor Welsh and Council President Karner supported the appointment of Sheila Tweedie to the Planning Board due to her vast experience and years of service to the Borough.

A brief discussion ensued with Mr. Cruz referencing the Municipal Land Use Law which provides for the Mayoral appointment of Class IV members of the Planning Board without the advice or consent of the Borough Council.

Mr. Cruz further advised that in order to provide a continuum of professional services for the Borough that the contracts that were previously pulled from the Consent Agenda and tabled until the January 22, 2024 Borough Council meeting should be reconsidered for approval and awarded for a contract period through January 31, 2024 only.

Motion by Council President Karner, seconded by Councilman Rinzler that Resolutions 24-021; 24-022; 24-023; 24-024, 24-030 and 24-036 be approved as amended to award the contract for a period through January 31, 2024.

PUBLIC COMMENT — The Mayor and Council welcome comments from any member of the public. To help facilitate an orderly meeting and to permit the opportunity for anyone who wishes to be heard, speakers shall limit their comments to 5 minutes.

Mayor Welsh opened the meeting for public comment.

Johanna McCarten, 38 Peapack Road, Far Hills stated that she had recently overheard several members of the Borough Council discussing who they would like to remove from the Borough Council and found the behavior disturbing and sad for our community.

George Mellendick, 260 Lake Road, Far Hills commented that people in the community may become more involved in serving if they were apprised of the opportunity.

Sohail Khan, 3 Fox Hunt Court, Far Hills commented that the way the Planning Board handled their responsibilities over the last several years, specifically regarding the Errico Acres (Pulte Homes/Kimbolton) development that none of them deserve to remain on the board. He also felt that there was a lack of transparency and notices to the public. Mr. Khan noted that several trees were removed on the site as well as in the buffer areas. Lastly, he commented upon the acceleration of the construction and cautioned against the Borough's ability to stop the project and to rectify any violations if construction was permitted to continue at this pace.

There were no further comments from the public.

Mayor Welsh closed the meeting for public comment.
