August 10, 2020 VIA CONFERENCE CALL ONLY

CALL TO ORDER

Mayor Vallone called the conference call meeting to order at 7:04 p.m. and read the open public meetings statement in accordance with the law.

REPORTS

Councilman Richard Hand - Fire, Water, Light, Buildings & Grounds

Councilman Hand reported that he contacted Nelson Tree Service to schedule a meeting to review tree trimming and removal work in the Borough and asked Council President Karner if he would also be able attend.

A brief discussion ensued regarding areas in need of weed whacking at the J. Malcolm Belcher Fairgrounds resulting in Ms. Hicks being asked to reach out to DPW Director, John Mantz for clarification of their scope of work.

Lastly, Councilman Hand indicated that Ms. Cindy Ehrenclou, Executive Director of Raritan Headwaters Association inquired about the installation of a sign to designate their property that runs adjacent to the Raritan River and extends beyond the Fairgrounds as a Natural Preserve. A brief discussion ensued resulting in a consensus to formulate a subcommittee to further review this request.

Councilwoman Tweedie - Health/Sanitation

Councilman McLean - Roads

Councilman McLean provided a brief overview of the road projects in the Borough.

Council President Karner inquired as to the status of the Ludlow Avenue and Dumont Road Drainage. Mayor Vallone responded that test sampling of the road way had been conducted and some relocation of the water infrastructure may be necessary. Ms. Hicks was asked to reach out to Ferriero Engineering for a timeline for the commencement of this project.

Councilwoman Chimenti - Laws, Ordinances, & Elections

Council President Karner - Police

Council President Karner indicated that Chief DeCarolis was unable to attend the meeting tonight but Council President Karner offered his congratulations to the DeCarolis family on the recent birth of their daughter.

Council President Karner provided an update on the recruitment efforts for a Class II Special Officer.

Council President Karner also reported that a branch had fallen on the fence at the Fairgrounds and asked that it be reviewed for remediation. He also noted that the roof for the gazebo was in need of attention and indicated that a local carpenter had offered his assistance.

Lastly, he informed the Council of the progress in the planning for the Borough's 100th Anniversary country picnic style event to take place on May 15, 2021 and emphasized the need to ensure that the Fairgrounds continued to be well maintained.

Mayor Vallone

Mayor Vallone also expressed his congratulations to the DeCarolis family on the birth of their daughter.

Mayor Vallone apprised the Council of the efforts undertaken to restore power to Borough residents as a result of Tropical Storm Isaias which affected nearly 800,000 people throughout NJ/NY/PA. He indicated that 100% of Far Hills was without power for a period of time and was largely attributed to dependency upon three different substations. He added that along with the Office of Emergency Management and the New Jersey State Police, there was constant communication with representatives from First Energy/JCP&L to ensure power was restored as soon as possible. Mayor Vallone indicated that continual updates were communicated to residents via Nixle and the Borough website and expressed his appreciation to all residents for their understanding and patience.
