**FEE SCHEDULE:**

Annual Dog License (per dog)	\$ 18.00
Annual Cat Certificate (up to 6 cats)	\$ 15.00
Not neutered or spayed (per animal)	\$ 3.00
Late Fee	\$ 10.00

**DUE DATE:** Applications are due by January 31<sup>st</sup> of the licensing year.

**LATE FEE:** After the 10 day grace period, a late fee of \$10.00 per dog license/cat certificate shall be assessed.

**APPLICATION CHECKLIST:**

- Complete application and mail to the above address - Attn: Borough Clerk – Pet License.
- Per Fee Schedule, check made payable to the “Borough of Far Hills”
- A copy of the rabies certificate, which must be valid through November 1, 2021.
